Having held a Pre-Hearing Conference on the date noted above, Inquest Administrator (IA) Spearman hereby orders the following:

1. Training Scope
  - a. In order to focus the training scope prior to the SPD Designee’s interview, the parties shall review the draft training scope and indicate by October 19, 2022, which trainings the party agrees should be included in the scope and which trainings remain in dispute.

- b. SPD has designated Lt. Dan Nelson as the Policy/Training Designee. The parties have tentatively scheduled Lt. Nelson's interview for October 27, 2022. Counsel for the Family shall inform the parties on October 14, 2022, whether they are available on October 27, 2022.
2. Having received no proposed witnesses from the parties by the October 7, 2022, deadline, no other witnesses (other than proposed experts) will be called to testify, except if a request by a juror to hear from a witness is granted by the IA.
3. Any Motion to Continue the Inquest Hearing shall be filed by October 14, 2022. Any response to a Motion to Continue shall be filed by October 18, 2022. Counsel shall also provide availability for December through February by October 18, 2022.
4. The parties received the Family's expert report from Dr. Quinn on October 10, 2022. Deadlines for SPD and the Involved Officers to disclose any proposed experts and produce any reports will be set after the Motion to Continue has been decided.
5. The Family shall produce any demonstrative video exhibit by October 14, 2022. A deadline to file any objections to the video exhibit shall be filed by October 21, 2022.
6. Briefing schedule re: informing jury re: Chief Ordering Involved Officers to testify – this agenda item is tabled at this time.
7. Final Proposed Jury Instructions will be provided to the parties by October 24, 2022, subject to revision at the close of testimony.
