Having held a Pre-Hearing Conference on the date noted above, Inquest Administrator (IA) Spearman, after consultation with the parties, hereby orders the following:

- 1. Policy Scope
 - a. The following sections are stricken:
 - i. 8.050 (use of force definitions weapons)
 - ii. 8.200(5) (deadly force for a fleeing suspect)
 - iii. 8.300(1) (use of force tools only carry weapons on which trained / certified)
 - iv. 9.030(4) (equipment required for deployment)
 - b. The following sections are retained or added:
 - i. 8.300-POL-4(7) (use of force firearms) (officers shall issue verbal warning))

- ii. 8.300(2) (use of force tools) (required to carry one less lethal tool)
- c. The updated Policy Scope Excerpt shall be provided to the parties by December 16, 2022.

2. Training Scope

a. SPD noted that the consent decree required SPD to develop new trainings and that, because those new trainings were implemented in November or December of 2015, any trainings taken by Ofc. Schickler before that were not relevant to the inquest hearing. It is unclear if Ofc. Schickler has taken any post-consent decree use of force trainings. SPD will update, by January 6, 2023, which, if any, trainings Ofc. Schickler has taken that are consistent with the consent decree. Any rulings on the relevance of prior trainings that Ofc. Schickler may have taken are reserved.

- d. The Family's request to call Ofc. Jared, Willard is denied.³
- e. The Family's and Involved Officer's request to call Ofc. Michael Snyder and the Involved Officer's request to call Ofc. Joseph Macniak are granted.
- f. The Family's request to call Denise Rodier (WSPCL) and the Involved Officer's request to call Brian Smelsmer (WSPCL) are denied at this time. The parties are encouraged to work with IPA Zangri in crafting a stipulation that encapsulates the expected testimony from these two witnesses in a way that is helpful for the jury.
- g. An updated witness list reflecting these rulings shall be provided to the parties by December 16, 2022.

4. Exhibits

a. A draft exhibit list will be provided to the parties by December 16, 2022. The parties will have an opportunity to provide input regarding the exhibits and any portions thereof, as well as propose exhibits for consideration.

5. Witness Interviews

- a. Interview of ME Dr. Williams is scheduled for December 9, 2022. The interview will be recorded and the Inquest Program will have a transcript prepared to share with the parties.⁴
- b. Parties will work to schedule interview of policy/training designee (Cpt. Gregg Caylor) the week of February 6 10, 2023.
- c. Parties to notify IPA Zangri of any other witnesses they wish to interview by December 16, 2022.

6. Use of Force Expert

a. IA Spearman has identified an expert on police use of force issues that he will likely retain on a consulting basis. The parties shall be advised promptly if, and when, that occurs.

³ As indicated orally at the PHC, the Administrator declines to call the witnesses listed in subsections (c) and (d) of this order, because of the limited relevance of their observations and potential testimony. The events that occurred at Scene 1 are relevant for two reasons: 1) It is the beginning of the sequence of events that led to the shooting and death of Mr. Seavers, and 2) any impact that those events may have had on the officers who participated in Scene 1 and/or were aware of the events that occurred there. Not every detail of what happened at Scene 1 is necessary to convey that information to the jury. The evidence that the Administrator intends to admit regarding Scene 1—including witness testimony, video from body-worn and in-car cameras and audio from the 911 calls—is sufficient to convey to the jury the significance of the events that occurred there. Nonetheless, the witnesses will be subpoenaed in the event a juror request to hear from one of them is granted.
