I am writing to urge the Inquest Program to support our request that the KCPAO grant Tyler Turpin use and derivative use immunity for the reasons outlined in our letter to Ms. Larson and Mr. Ernsdorff. The Inquest Program reformed its rules in order to achieve greater transparency into incidents where people die during encounters with law enforcement. By joining us in encouraging the KCPAO to grant immunity to involved officers, the Inquest Program would be advancing its interests in ensuring that inquests are transparent proceedings in which all parties participate.

We respectfully request that the Inquest Program join us and urge the prosecutor's office to grant Officer Turpin use and derivative use immunity. Thank you.
