Hi Ghazal,

Thanks for being in touch. As I am sure you are aware, Executive Constantine has finalized his Executive Order, which lays out the scope of reformed inquest process in detail. In the past, the inquest process has relied exclusively on the executive order in effect at the time to govern the scope of discovery, and I have no information to suggest that it would be any different moving forward. With that in mind, I am not sure what additional parameters you are referencing. I have attached our request for supplemental discovery to this email. All of the information should be comfortably within the scope of the revised inquest process. Its worth noting that some of the information requested (e.g. Officer Anderson and Officer McNew's complete DICV, the 3D model of Charleena's apartment, etc.) should have already been provided in the initial discovery disclosure, even under the most narrow reading of the old inquest rules. Other materials, such as training manuals, clearly fall within the scope and have already been provided through discovery for some areas (i.e. a taser training manual and course), so I don't see why providing those types of documents in other areas would pose any problem.

We would request that SPD review the requested documents and provide the information that is clearly disclosable in its entirety, either because it should have already been disclosed or because it clearly falls within the revised inquest scope. I anticipate this will be all or nearly of the records we are requesting. In the event that SPD believes that a document is not within the scope of the revised inquest rules, we would request that SPD explain why it believes the document falls outside the inquest scope and then provide the document subject to relevant public disclosure redactions.

We do not believe treating this request as a standard PDR request is a meaningful attempt to provide assistance. If this request is treated is a standard PDR request, we won't receive documents (some of which should have already been provided) in a timeframe that is even remotely useful to us in preparing for the inquest. For example, eight months ago, in an unrelated matter, I submitted a PDR request to SPD for a small subsection of trespass police reports. Each report is very short, typically with a narrative section of about a paragraph. Over the past eight months, I have only received 28 police reports from SPD. If this rate of production were applied to the Lyles inquest, it would take many years, likely decades, to receive all the documents that should be provided.

Given Chief Best's promise to the family to provide information as quickly as possible, I would expect that SPD would understand why the standard PDR timeline I described above is not a meaningful attempt to provide assistance. Additionally, in the same discussion I am referencing, Chief Best explained that she was limited in what information she could provide because of a "pending inquest." Its difficult to reconcile how SPD could claim that it cannot provide a family member information due to a pending inquest, and then deny a request for information from inquest counsel for that family member because the inquest is not active.

Thanks for following up on depositions. One of my clients

, so I haven't been able to work on deposition scheduling with the family. Unfortunately, my co-counsel is now out of the country for the next two weeks. I will make sure to have a response for you by January 14th. I appreciate you working with us on this, and would expect that you won't need to use compulsory process.
