Having received Motions to Continue from the Involved Officers and SPD, and a response from the Family, the Inquest Administrator (IA) Spearman hereby orders the following:

1. The Inquest Hearing is continued from November 7, 2022, to March 27, 2023, with an expected end date for testimony of April 7, 2023, and April 10 and 11, 2023, for jury deliberation, if necessary.
2. Additional information requested by IA Spearman from the Involved Officers and SPD regarding trainings that should be included in the IA's final Training Scope shall be submitted by November 8, 2022.

3. The final Training Scope will be issued by IA Spearman on or before November 15, 2022.
4. Involved Officers shall produce Dr. Wigren's report on or before November 18, 2022.
5. Involved Officers shall disclose the name of any video expert by November 10, 2022, and provide any report or indicate that no expert will be designated as a requested witness by November 30, 2022.
6. IA Spearman intends to add the following policy Task to the Policy Scope:

**16.110-TSK-2 Requesting AMR for Transportation to Either a Local Hospital or King County Jail**

When requesting AMR for transportation to either a local hospital or the King County Jail, the officer:

1. Requests the AMR transport through either the zone dispatcher or the Data Channel
2. When making the request, discloses the nature (Crisis or Behaviorally Out of Control Subject) of the incident as well as the desired transportation destination (i.e. KCJ or Hospital)
3. If applicable, reports if the person to be transported is wheelchair bound.
  - a. If the person to be transported is bound by a wheelchair, reports if it is a folding chair or electric.

Any objection to including 16.110-TSK-2 to the Policy Scope shall be submitted by November 18, 2022.

7. A Pre-Hearing Conference is set for December 2, from 10:00 a.m. to 12:00 p.m. via Zoom Webinar.
